<b>1.0</b>	<p><b><u>WELCOME</u></b> The meeting was opened with a welcome from JW</p> <p><b><u>APOLOGIES</u></b> None</p> <p><b><u>MINUTES OF PREVIOUS MEETING – 21<sup>st</sup> November 2013</u></b>                  Approved by JM, seconded by CH</p>	
<b>2.0</b>	<p><b><u>POLICE REPORT</u></b> – PC Claire Smith had been asked to attend by Inspector Conway as local police on leave.                  2 serious assaults that had previously been reported.                  No issues arose at switching on of Christmas Lights or at Firework Display.                  Directed Patrol Plan has been put in place – focusing on violence and disorder; bogus workmen; disqualified drivers and drug offences – this will continue over the next few months.                  Housebreak-ins continue to be a concern – this is the case all over – figures include break-ins to outhouses and garages – plain clothes officers are being used to help.                  RS commented on new leaflets and stickers that have been produced by Community Safety in the campaign against bogus workman – will bring a sample to next meeting.</p>	
<b>3.0</b>	<p><b><u>CRAIG CROSTHWAITE – NORTH AYRSHIRE FOODBANK</u></b>                  Craig gave a very interesting and informative chat on the Foodbank.                  Launched 1<sup>st</sup> Dec.'12 – initially expected to distribute about 400 boxes annually, but in one year have already distributed nearly 3,000. Indications are that this will continue to increase. Most boxes are distributed in a one off crises situation. Run completely by volunteers. More accessible distribution points for boxes are needed. Outside agencies, not the Foodbank, provide the vouchers for the boxes. Boxes are carefully nutritionally balanced. Kilwinning does have some, but not a large amount of requests for boxes. Planning a link with schools. 60% of food is donated at supermarket collections. Over 25 tonnes of food have been donated throughout the year, with 22 tonnes being distributed.                  KCC donated a number of bags of food brought along on the night, for which Craig was very grateful.                  JW thanked Craig and asked that if he felt that KCC could help in any way that he please contact us.</p>

8.0	<p><b><u>AOB</u></b></p> <p>8.1 JW - Nairn McDonald has now had his 18<sup>th</sup> birthday, and is, therefore eligible for membership of KCC, Co-Opted – proposed by JW seconded by SK.</p> <p>8.2 JW - <b><u>Abbey Grounds &amp; Tower</u></b> Increasing amounts of damage and destruction within the Abbey Grounds. This is a concern to many groups. Police have already had complaints from Kilwinning Old Parish. JW asked PC Smith to report to colleagues on concerns of KCC. PC Smith acknowledged that the local police are aware of the issues and are addressing the situation. Long discussion ensued as to the cause and the possible preventative measures that could be put in place to alleviate this problem. All agreed that this is a project, not just for KCC, but for many other groups in the town – including residents, schools, the college, Churches and community based organisations. Agreed to consider this and discuss in January.</p>
